#### TERMS OF USE

Welcome to www.thejillsofalltrades.com (the "Site"), provided to you by The Jills LLC, doing business as The Jills of all Trades ("The Jills of all Trades", "we" or "us"). This website is an online platform through which business entities (hereinafter referred to as "Businesses") requesting projects to be completed hire persons (hereinafter referred to as "Contractors" or "Contractor") to complete such projects (hereinafter referred to as "Business Projects"). The Jills of all Trades provides services to you in your capacity as either a Business or a Contractor. Our services include connecting supporting and promoting independent professionals and connecting business to project based talent (together, the "Service").

This Agreement includes and hereby incorporates by reference any agreements and policies referred to herein, including any policies on <a href="www.thejillsofalltrades.com">www.thejillsofalltrades.com</a>. Such agreements and policies may be modified by The Jills of all Trades from time to time in its sole discretion. In the event of a conflict between such policies and agreements and this Agreement, this Agreement controls.

Both Businesses and Contractors shall be deemed "Users" for the purposes of this Terms of Use (this "Agreement"). The following Terms of Use apply when you view or use the Service. Please review the following terms and accompanying Privacy Policy carefully. By submitting information, creating a The Jills of all Trades profile (a "Profile"), accessing or using the Service or otherwise using the Site, you signify your agreement to these Terms of Use. IF YOU DO NOT AGREE TO THE TERMS OF USE, YOU MAY NOT USE THE SITE OR ACCESS THE SERVICE.

### 1. THE SITE AND SERVICES

- 1.1 Services. The Jills of all Trades supports and promotes independent professionals and connects business to project based talent The Jillsofall Trades.com enables Businesses seeking talent to search for, and communicate with, independent contractors in areas that include, but are not limited to, web and mobile development, accounting and bookkeeping, design, community management, social media, journalism, marketing, and public relations.
- 1.2 Site is a Platform or Venue. The Site provides a platform, i.e. a venue for Businesses looking for Contractors to assist Companies with various Business Projects. The Jills of all Trades is not a referral, matching or placement service and does not provide, refer, place, offer or seek to obtain employment or engagements for any of its Users. The Terms of Use apply only to the use of the Site and Services. In the event that a Business is interested in hiring a Contractor, the Contractor must enter into an agreement with The Jills of all Trades, which will control the terms of the new relationship between the Contractor and The Jills of all Trades.
- 1.3 No Background Checks. The Jills of all Trades does not verify the identity, background, training or experience of any of the Users, or any content submitted by a User or anyone other than The Jills of all Trades, including but not limited to User profiles and reviews ("User Content"). As a result, The Jills of all Trades has no control over the accuracy, reliability, completeness or timeliness of profiles, reviews, background check information, affiliations or

other User Content submitted on the Site, and makes no representations about any such User Content on the Site

- 1.4 Vetted Contractors. The Jills of all Trades, at its sole discretion, may assess a Contractor to verify a Contractor's skills and abilities ("Vetted Contractors") and identify Vetted Contractors on its Site for informational purposes. The Jills of all Trades may also provide Businesses with a customized list of potential Contractors to consider based on the information that Business provides regarding its needs and preferences. The Jills of all Trades makes no representations or warranties regarding the skills or abilities of Contractors or Vetted Contractors. The Jills of all Trade's internal assessment of Vetted Contractors shall not be viewed as complete, accurate, upto-date or conclusive of the individual's suitability for a particular position.
- 1.5 No Representations about Users. The Jills of all Trades further makes no representations about the Businesses or the Contractors. You should make your own assessments of the persons you decide to interact with, engage or provide services to. We do not assume responsibility for the conduct of, or quality of the services provided by, the Contractors. Any issues concerning the foregoing must be resolved directly by the Business and Contractor.
- 1.6 The Jills of all Trades is not an employment service and does not serve as an employer of any User. As such, Users are solely responsible (and The Jills of all Trades is not responsible), for any tax, withholding or reporting, including, but not limited to, unemployment insurance, social security or payroll withholding tax or income reporting (if applicable) in connection with any services provided by Users. You understand and agree that if The Jills of all Trades is found to be liable for any tax, withholding tax or reporting obligation in connection with any services provided or received by you, then you will immediately reimburse and indemnify The Jills of all Trades for all costs, expenses and liabilities (including any interest and penalties) relating to the same. ("Affiliated Parties" means The Jills of all Trades officers, directors, members, agents, assignees, representatives, marketing partners, licensors, independent contractors and employees.)

# 3. USE AND CONDUCT RESTRICTIONS

3.1 Registration and Account Information. When you register for the Site, you will be asked to create an account and to provide us with certain information about yourself (your "Information"). Your Information will be used in accordance with The Jills of all Trade's Privacy Policy. You are responsible for providing accurate, current and complete information in connection with your account registration.

As a User, you are responsible for maintaining the confidentiality of your password and account login, and you are solely responsible for all activities that occur under your password or account. You agree to immediately notify us of any unauthorized use of your password or account.

We do not control or endorse any Third Party Site or advertisements, and we are not responsible for any content, product, advertising and other materials presented in or provided by such Third Party Site or advertisement. Your use and access of a Third Party Site is at your own risk, and is subject to the terms and conditions for such Third Party Site.

# 6. PAYMENT

6.1 Fees. You agree to pay The Jills of all Trades all charges associated with the plan that you subscribe to as described at the Site at the time you subscribe (your "Subscription") and provide accurate payment information. You authorize The Jills of all Trades to charge your chosen

payment provider according to the terms of the plan to which you subscribe. or qualifications of any Business or Contractor or the quality, security or legality of any Contractor's work on any Business Project, and disclaims any and all liability relating thereto.

The Jills of all Trades does not direct, has no control over Business Projects, and makes no representations as to the quality, safety or legality of any Business Project, the truth or accuracy of Profiles, the qualifications, background, or identities of Users, the ability of Contractors to perform Business Projects, the ability of Businesses to pay Contractors, or that a Business or Contractor can or will actually complete a transaction.

The Jills of all Trades may provide information about a User, such as a rating or third party feedback, but such information is based solely on data that Users or third parties submit.
